NOTICE OF PUBLIC MEETING

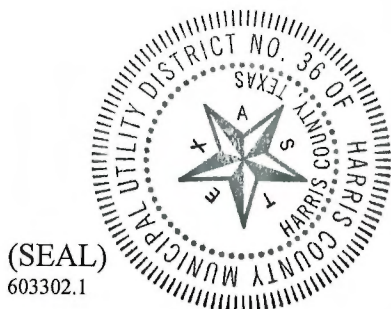
Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 1400, Houston, Texas 77056, said address being a meeting place of the District.

The meeting will be held on Thursday, November 11, 2021, at 12:00 Noon.


The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Public comments;
2. Review and approval of minutes of the October 14, 2021, Board of Directors meeting;
3. Bookkeeper's Report, including review of financial and investment reports, authorizing the payment of invoices presented;
4. Status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting;
5. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented and moving of accounts to uncollectible roll;
6. Report of and legal action taken by the District's delinquent tax collection attorney, including authorizing foreclosure proceedings, installment agreements and the filing of proofs of claims;
7. Operations Report, including:
 - (a) Monthly Report;
 - (b) Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same;
 - (c) Any appeals of District charges; and
 - (d) Authorization of the repair and maintenance of District facilities;
8. Implementation of Senate Bill 3 from 87th Session and amendment to District Rate Order in connection with same;
9. Report on the District's generator, including:
 - (a) Status of receipt of revenues associated with running during Winter Storm Uri, and review of report in connection therewith;

10. Engineer's Report, including:
 - (a) Authorizing the design and/or advertisement for bids and/or award of construction contracts, and authorize acceptance of TEC Form 1295, for the construction of facilities within the District, and approving of related storm water plans;
 - (b) Status of construction of facilities to serve land within the District, including the approval of any change orders, including:
 - i. Wastewater Collection System Rehabilitation, Phase I (Texas Pride Utilities, LLC); and
 - ii. Wastewater Collection System Rehabilitation, Phase II (T. Gray Utility & Rehab);
 - (c) Acceptance of site and/or easement and/or utility conveyances for facilities constructed or to be constructed for the District for operation and maintenance purposes;
 - (d) Status of Storm Water Quality Permits; and
 - (e) Requests for Utility Commitment Letters;
11. Developer's Report;
12. Authorize attorney to file Eminent Domain Report with Texas Comptroller of Public Accounts prior to February 28, 2022, pursuant to §2206.154, Texas Government Code;
13. Matters related to Directors Election to be called for May 7, 2022, including (i) notification to Harris County officials that the District intends to participate in the joint election; (ii) publication of notice regarding accessible voting systems, and (iii) posting of Notice Regarding Candidate Filing Period;
14. Attorney's Report;
15. Matters for possible placement on future agendas.
