The meeting will be held on Thursday, January 11, 2024, at 12:00 Noon.

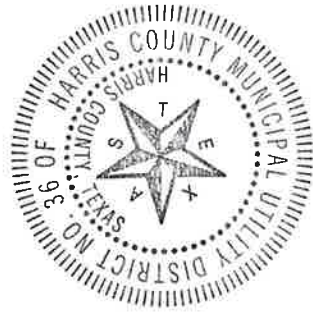
The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Public comments;
2. Review and approval of minutes of the November 9, 2023, special Board of Directors meeting;
3. Appointment of new Director(s) to fill the vacancy on the Board of Directors, including the following matters:
 - a. Acceptance of Qualification Statement, Bond, Oath of Office, Affidavit of Current Director and Election Not to Disclose Certain Information of new Director(s);
 - b. Election of officers of Board of Directors;
 - c. Approval of amended District Registration Form relative to the above;
 - d. Authorize preparation and maintenance of a local government officers list in connection with conflict of interest disclosure requirements;
 - e. Discuss training requirements memorandum for new Director(s) pursuant to the Texas Open Meetings Act and the Texas Public Information Act, and the procedures for compliance with same; and
 - f. Discuss conflicts disclosure statement reporting requirements memorandum for new Director(s);
4. Bookkeeper's Report, including review of financial and investment reports, authorizing the payment of invoices presented;
5. Adoption of Resolution Adopting List of Qualified Brokers Authorized to Engage in Investment Transactions with District;
6. Review and approve audit for fiscal year ended September 30, 2023 (due February 12, 2024); authorize execution of Annual Filing Affidavit;
7. Status of continuing disclosure report (due March 30, 2024);
8. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented and moving of accounts to uncollectible roll;
9. Report of and legal action taken by the District's delinquent tax collection attorney, including authorizing foreclosure proceedings, installment agreements and the filing of proofs of claims;

10. Adoption of Resolution Authorizing an Additional Penalty on Delinquent Personal Property Taxes and authorize delinquent tax attorney to collect delinquent personal property taxes beginning April 1, 2024, including the filing of lawsuits, as necessary;
11. Grant exemptions from taxation for 2024, and the adoption of a Resolution in connection therewith;
12. Authorize preparation and submission of District information to Texas Comptroller of Public Accounts as required by Section 403.0241, Texas Government Code, and Chapter 203, Texas Local Government Code, for inclusion in the Special Purpose District Public Information Database;
13. Operations Report, including:
 - a. Monthly Report;
 - b. Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same;
 - c. Any appeals of District charges;
 - d. Authorization of the repair and maintenance of District facilities; and
 - e. Report on District's water accountability, including status of testing of commercial water meters through the District;
14. Authorize operator to provide required information to districts receiving water from the District relative to Consumer Confidence Reports;
15. Engineer's Report, including:
 - a. Authorizing the design and/or advertisement for bids and/or award of construction contracts, and authorize acceptance of TEC Form 1295, for the construction of facilities within the District, and approving of related storm water plans, including:
 - i. Water Distribution System Rehabilitation/Replacement;
 - b. Status of construction of facilities to serve land within the District, including the approval of any change orders;
 - c. Acceptance of site and/or easement and/or utility conveyances for facilities constructed or to be constructed for the District for operation and maintenance purposes;
 - d. Status of Storm Water Quality Permits;
 - e. Requests for Utility Commitment Letters;
 - f. Discussion regarding City of Houston Groundwater Reduction Plan and outlook for District compliance with same; and
 - g. Review of updated Capital Improvement Plan; authorize any action necessary in connection therewith;
16. Report on the District's generator;
17. Developer's Report;
18. Discussion of renewal of District insurance coverages and authorize solicitation of proposals for same;

19. Matters related to Directors Election to be called for May 4, 2024, including (i) memorandum regarding independent and joint elections, (ii) notification of Harris County officials that the District intends to participate in the joint election if Harris County offers joint election services, and (iii) discussion regarding accessible voting systems, and take any action necessary or appropriate in connection therewith;
20. Attorney's Report;
21. Supplemental Agenda in English, Spanish, Vietnamese and Chinese regarding calling Directors Election; and
22. Convene in Closed Session pursuant to Open Meetings Act, Section 551.074, 551.072 and/or Section 551.071, Texas Government Code;
23. Reconvene in Open Session and authorize any action resulting from matters discussed in Closed Session; and
24. Matters for possible placement on future agendas.
